• Created Google for Nonprofits account in November 2024 (\$12/year) but we are not using it. Would like to cancel this subscription, but *could not figure out how, so deleted payment method.* Google system kept trying to delete my personal gmail and the regular Ripple gmail/google accounts.



- Called IRS Non-Profit Tax Law Department regarding 501(c)3 status <u>application 123-EZ</u> due to concerns brought forth by Ripple Treasurer during fall 2024
 - Person I spoke with said if the application was approved, there is no problem with the answers submitted.
 - □ He said, if the IRS had a question or needed more information about why we selected a given answer, they would have sent a letter asking for more information
 - □ Checking some of these boxes "yes" leaves room for possible future operations to encompass these activities. See wording of the questions: "do you or will you…"
 - □ The answers do not affect tax submission in any way.
 - □ We just need to make sure that the bylaws contain reference to these activities. That is the part that needs to be addressed.

• Vote to add section: approved by vote kelly and steve <u>ARTICLE XIII: ACTIVITIES</u>

As part of the organizational activities of this non-profit, funds may be donated to pay for individuals' acupuncture and herbal expenses and grants may be offered to individuals or organizations (inside or outside the United States). Disaster relief efforts may also be offered in conjunction with this organization. • Registered Agent (RA): all non-profits are required to appoint a Registered Agent with a street address. Anyone with a street address can be a registered agent or you can pay someone to do it. A business can't appoint itself as RA, but an individual owner can.

- Proposed changes to mission statement:
