- (9/23/24) RE: Free Accounting Software (online) Examined ZipBooks (<u>zipbooks.com</u>) and Wave (<u>www.waveapps.com</u>) software websites.
  - Set up a free account using my email and explored both websites. I had used Wave for a few months before (circa 2016) so I was a little familiar with the layout.
  - After exploring ZipBooks, I would recommend using Wave.

ZipBooks frequently tries to up-sell product features and I almost
accidentally signed up for a pay feature without knowing it (would be too
easy to repeat this, because of how the website is designed).

☐ Wave does have higher tiers, but it didn't appear to push or force you to use specific content to work on the website. Strongly prefer Wave for the level of accounting services we need.

**NOTE:** Might be a good idea to have a broad email that we can all access. Sending keydata through my email alone might not make things easier. It might be better to have a general email like "<u>info@ripple.com</u>" or something gmail based, that way the information is distributed.

This email account should be used for all organizational communication purposes so that there is a single e-paper trail that we can all access/follow if needed. It was created with the intention of being used solely for the organization. I have my
